1. Until the 1830s the parish of Dysert included the area comprised in the present civil parishes of Dysert, Inagh & Ruan. The outline of this old parish can be seen in Petty's *Hibernia Dileneatio*, the first county atlas of Ireland dating from 1660-1675. It survived as a single parochial unit until the early part of the nineteenth century when Grand Juries were empowered to create new divisions, including the division of baronies, under legislation known as the Boundary Code. The civil parishes of Dysert, Ruan and Inagh, carved out of the old division, appear for the first time as separate civil parishes in the census of 1841.
2. This was a 'plantation acre' reckoned at 140 perches or poles, each perch or pole consisting of 21 feet as against 16½ feet to the English measure.
3. i.e. By 'final determination' by the Court of Claims and Qualifications sitting at Athlone. The court was set up in 1654 to determine the level of guilt or "qualification" of the 'rebel' landowners, and to determine the amount of land they were to be allotted in Connacht or Co. Clare.
